WHAT COUNTS AS A KIT?

- What your library might define as a kit might not be a kit for cataloging purposes
 - For example: book + CD, a game, etc.
- Kits are not mentioned in RDA
 - There are no rules! Mwahahahaha!
 - The AACR2 definition is "an item containing two or more categories of material, no one of which is identifiable as the predominant constituent of the item"



WHAT COUNTS AS A KIT?

- Some are published as "kits" and might already be in OCLC
 - How do you know when to make a kit in OCLC vs. a local record in Polaris?



245: TITLE AND STATEMENT OF RESPONSIBILITY

- This is probably going to be made up
 - If it's a series of kits, try to keep it consistent
 - For example: "Backpacking adventure kit" and "Caving adventure kit"
- Make sure to check instruction sheets, kit contents sheets, and containers
- Always add a 588 0_ note with the source of title
- Unlikely to have a statement of responsibility



- Not used in RDA
 removed from records in OCLC
- SHARE local practice: add GMD to non-print format records in Polaris
 - Do this for kits even if all the materials are books
 - Subfield h comes after subfields a, n, and p
 - Subfield h comes before subfield b
- Example: 245 00 \$a Grave robbing adventure \$h [kit].



250: EDITION STATEMENT

- Source is anywhere on the item
 - Transcribe it exactly as you see it
- If taken from an outside resource, such as a website, put in brackets
- Unlikely to have this if it's something your library created



264: PUBLICATION INFORMATION

- For our purposes, if it's a kit that your library put together, then consider your library as the publisher
- You can have repeated 264 fields for different functions with appropriate second indicators
 - Producer (0), publisher (1), distributor (2), manufacturer (3), and copyright date (4)
 - Nothing is technically "core", so just put whatever information you can find
 - This is for the whole kit, not the various parts

DATES AND PLACES FOR PUBLICATION

- Publication date: see if there is a date on the container or use the copyright date as the implied publication date
- If your library created the kit, then put the year of creation in brackets. Also, use your town and library name for subfields a and b
- Example: 264 _1 \$a Edwardsville, Illinois: \$b Illinois Heartland Library System, \$c [2023]
- Example: 264 _1 \$a Chicago, Illinois: \$b Mattel, Inc., \$c [2018]

300: PHYSICAL DESCRIPTION

- 300 \$a extent
 - Use format: 1 kit (kit components)
- 300 \$b other physical details
 - Sound? Color? Type of materials? Etc.
- 300 \$c dimensions
- Example: 300 ___ \$1 kit (1 frame board, 20 magnetic counters, 100 small counters, 1 kit contents card): \$b color, foam, plastic; \$c in bag, 38 x 35 cm

336, 337, 338: CONTENT, MEDIA AND CARRIER TYPES

- Add all applicable fields
- If your kit is only books, you would just have the same ones that you would normally use for books
- 336 is content type, 337 is media type, and 338 is carrier type
- Add "other" 337 and 338 to with multiple content types
 - 337 ‡a other ‡b x ‡2 rdamedia
 - 338 ‡a other ‡b nz ‡2 rdacarrier



33X FIELDS EXAMPLE

Your kit includes 2 DVDs, some picture books, a game, and some plastic figurines

- 336 ‡a three-dimensional form ‡b tdf ‡2 rdacontent
- 336 ‡a two-dimensional moving image ‡b tdi ‡2 rdacontent
- 336 ‡a text ‡b txt ‡2 rdacontent
- 336 ‡a still image ‡b sti ‡2 rdacontent

340 FIELDS: PHYSICAL MEDIUM

- Record each term in a separate 34X field (per OCLC)
- Use controlled vocabulary terms where possible
 - Links to lists can be found in Bibliographic Formats and Standards for the field and subfield
 - 340 PHYSICAL MEDIUM (OCLC.ORG)
 - Enter the code for the list in \$2
- Not every term is included in an RDA Registry List
 - If not using a term from a controlled list, omit \$2

RDA REGISTRY VOCABULARY

Subfields

+a Material base and configuration

The material base (physical substance) and configuration on which the information is recorded. Material bases include audiotape, cartridge, chip, dot, fiche, globe, magnetic tape, microtape, sheet, ultratape, and videotape. For a list of RDA-controlled terms, see RDA Material.



34X FIELDS CONTINUED AND 380 FIELD

- Record as applicable
 - If you have a kit with DVDs, also include the 34X fields that you would normally include in a DVD record
 - Example: 341 _0 \$a auditory \$b captions

347 _ _ \$a video file \$2 rdaft

- Use \$3 to denote which component you're describing, as needed
- If you want to add a 380 field for form of work, you could use the AAT term "kits (sets)", since that thesaurus is now approved for use!
 - 380 __ \$a Kits (sets) \$2 aat
 - Art & Architecture Thesaurus Full Record Display (Getty Research)




5XX FIELDS: NOTES

- Who compiled the kit/why the kit was compiled, Cost of kit replacement, etc.
- More specific breakdown of kit contents
 - Example: Includes book: Going Along the Emigrant Trails / Barbara Fifer. Helena, Montana: Faircountry Press, ©2006.
- 588 0_ : Source of title note
- 520: Summary of the kit and description of how to use it
- Any warnings: small parts, choking hazards, etc.
- 521 (with appropriate indicators): Audience note
- Where various items were made, etc.

SUBJECT HEADINGS

- Add as applicable for the subjects of the kit as a whole
 - Example: 650 _0 \$a Frogs.
- Topical, geographic, and names
- No need to add \$v
- Also add local subject heading for kits
 - 690 \$a Kits.
- Add all applicable genre headings for every type of item within the kit
 - 655 _7 \$a Picture books. \$2 lcgft
 - 655 _7 \$a Educational games. \$2 lcgft



- 020- international standard book number (ISBN)
- 024– UPC or other standard number
 - First indicator 1 for UPC numbers
 - First indicator 8 for unspecified number or code
- 028– publisher or distributor number
- Call numbers
 - Example: 082 04 \$a 597.8 \$2 23/eng/20230314
- Can also use local call number field
 - 099 is for Local Free-Text call number



COMMON OXX FIELDS

- 041 language code
- 043 geographic
 - You can use an OCLC Macro to add this
 - Or use this link: MARC CODE LIST FOR GEOGRAPHIC AREAS (LIBRARY OF CONGRESS) (LOC.GOV)



MARC TAG 007

- For kits: \$a o \$b u
- For unspecified items that don't match other categories: \$a z \$b z
- Don't use 007 Tactile Material unless it's for Braille
- Can add the ones for DVDs/Blu-rays/CDs, etc., but they will make the icon wrong so leave them out of the Polaris records

AUTHORIZED ACCESS POINTS

- Add access points for author names, and illustrators by which you want patrons to search
- Basically, add whatever you would normally add to records for the various components
 - If you have multiple books and multiple movies, this can get quite long!
- 730: Container of work, etc.
 - Have these for books, movies (and their corresponding audio tracks), audiobooks
 - Example: 730 0_ \$i Container of (work): \$a Dunn, Mary R. \$t Frog's Life Cycle.
- Use the full relator term, not the code (local practice)



LOCAL PRACTICES

- Add 945 \$b OCLC DO NOT SET
 - For kits that you want to keep local
- Remember to add the GMD
- Add local subject heading: 690 \$a kits
- Use the full relator term in subfield \$e for authorized access points
