History of Methodism in New Lenox.

On this auspicious occasion, being the 12th day of July, A.D. 1899, while we lay the corner stone of this church, and our hearts are filled with hope for the future of Methodism in this community, it is especially fitting that some attention be paid to the history of early Methodism in New Lenox and the surrounding country, so the following brief record has been prepared to be placed in this corner stone.

Prior to 1845 in New Lenox, Illinois, services of the Methodist Episcopal church were held at irregular intervals in the homes of Abraham Francis, Thomas Francis, John Cooper, William Gougar, and other early settlers. In their pioneer days the Rev. S. A. Briggs, who lived during the later years of his life at Plainfield, Illinois, but who is now deceased, was a circuit rider and preached throughout much of Northwestern Illinois to small congregations at widely separated intervals of time and distance. In his journeyings through the country he stopped

preaching, the official board of the church held a business meeting in a shed that stood some distance from the barn. Upon the completion of their deliberations, the official board became anxious to hear the young minister's discourse. But not wishing to disconcert him by entering the congregation while he was in the midst of his sermon, they decided to go into the basement of the barn, which was large, and listen to the young man's remarks from there.

The audience was assembled on the bare floor, and the young minister occupied a position where he could not see the official board enter the basement. Now it happened that the heat of the day had driven the greater part of Mrs. Francis' large stock of poultry to the basement for shelter from the sun. As soon as the official board entered the basement of course the geese, chickens and ducks began to scamp for any hole they could find through which to escape. The result was such

In 1863 the Bethel Church was torn down. The material in the structure was used in the building of a new church at the village of New Lenox, which is platted as the Village of Tracy. The building was erected on Lot 6 Block 6. The parsonage of Bethel Church was sold to Smith Reynolds, who moved it on to the farm now owned by Henry J. Schumbl. The building is now a part of Mr. Schumbl's dwelling house.

At the same time that a church building was erected at New Lenox, a church and also a parsonage were built at Frankfort Station, and the two places were served by one minister, the Bethel Church thus being enlarged into the Frankfort and New Lenox charge.
