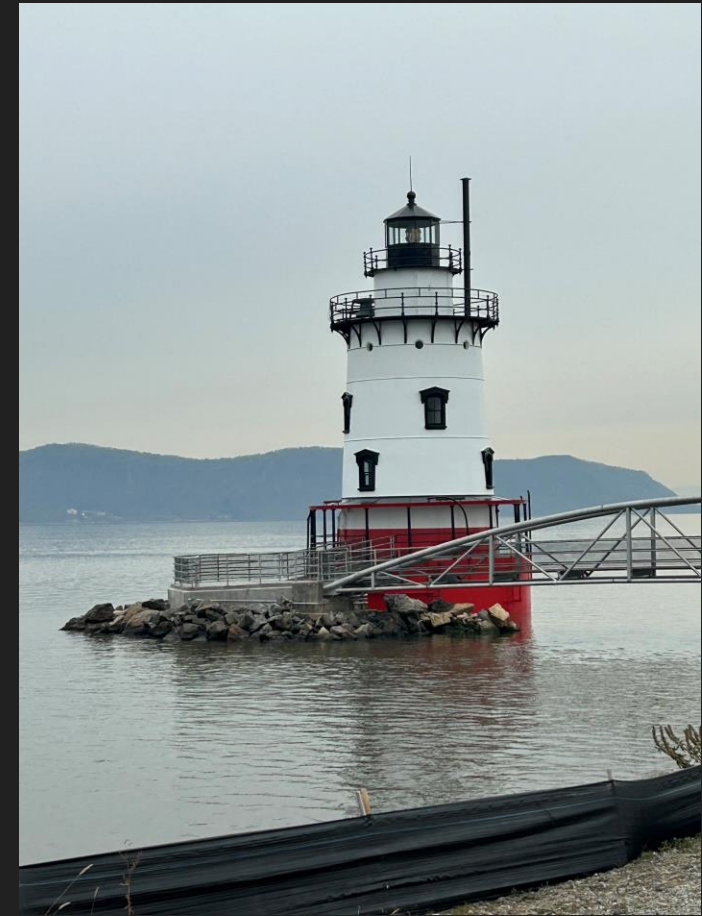
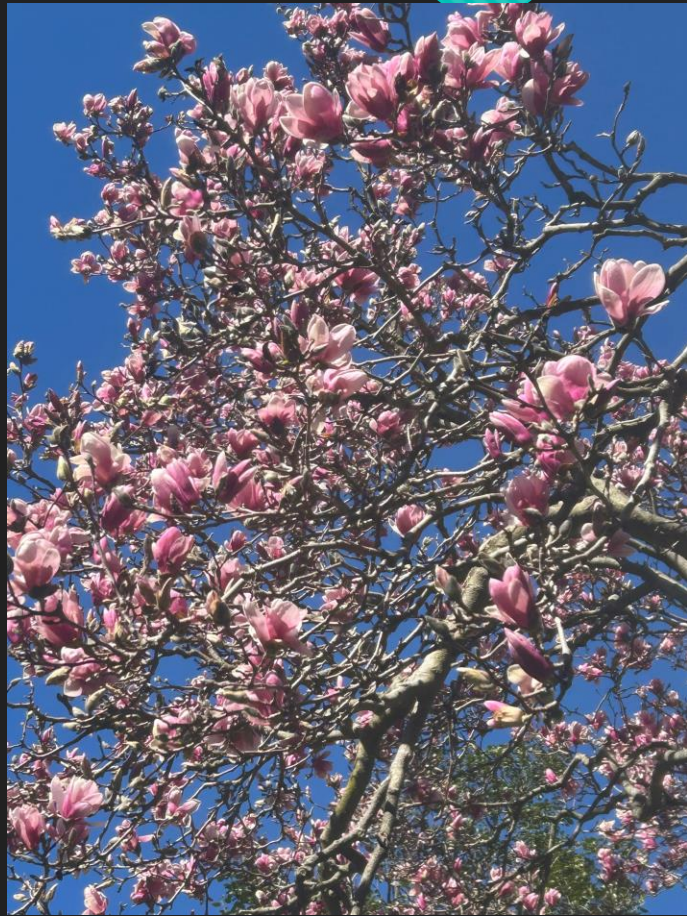

520	3	This review begins with the 2012 murder of Trayvon Martin, the subsequent launching of the Black Lives Matter movement and organization, the impacts of gun violence due to police brutality, anti-black violence, and community violence, the statistics of gun-related shootings and deaths in Chicago from 2015 to present, and Saint Sabina's response to gun violence via the summer community walks. The Faith Community of Saint Sabina is located on 79th and Racine in the Auburn-Gresham neighborhood. The church, led by Father Pflieger, is a pillar of social justice and support in the community. Saint Sabina is heavily focused on community outreach, having over 30 ministries focused on taking care of others. Peacemakers, Saint Sabina's social justice ministry, started the community walks in 2012 to offer mediation among gang members and as well as alternate options such as GED classes and internships. Over the last seven years, the community walks became a staple of the summer for Saint Sabina, occurring every Friday beginning the Friday after Chicago Public Schools are dismissed for summer break. Such dignitaries such as State's Attorney Kim Foxx and Mayor Lori Lightfoot have been present in recent years at the kick-off celebration, which is attended by at least 400 people. However as the weeks continue throughout the summer, participation dwindles, and weekly participation is approximately 50 people. Because Father Pflieger's measure of ministry is effectiveness is participation, this review considers how Saint Sabina can increase participation in the weekly community walks, thus increasing community visibility and becoming a more effective deterrent to community violence. There are many reasons the parishioners do not attend the community walks including, some members are not involved in the world of the church enough, some have schedule conflicts, some feel overwhelmed by the frequency of events, and some don't even know the importance of their involvement. Therefore, in response, Saint Sabina should theologically root its congregants in the reasons for the community walks, other social justice initiatives, and the importance of full participation through a Bible study, whose proposal is offered in chapter 4. The organizing committee should also encourage at least 2 representatives from each of the 37 ministries to participate in the weekly walk, which can potentially increase participation by 74 people. Other local organizations as well as former and present gang members should be invited personally to foster positive community relationships. Saint Sabina should also increase the use of its social and print media to advertise the weekly event. As well, leadership should continuously examine the logistics of the community walks to ensure they still align with the needs of the community and assess how the community walks are received by the neighborhood to ensure effectiveness. The Bible study proposal is available to reiterate these messages. The Bible study is a 3-part Bible uses the story of Habbakuk to teach about having a vision in ministry, doing the work of ministry, and understanding the rewards and sacrifices. Of course, due to COVID-19, there were no summer walks this year. However

520									3 Infidelity is cited as one of the most traumatic events experienced in a relationship and is reported as the most common cause of relationship dissolution across cultures. Regardless of the type of infidelity experienced (sexual, emotional, technological, or a combination of various types), there is clear evidence that detrimental consequences result following an experience of interpersonal betrayal such as infidelity. Although forgiveness and healing following infidelity are possible, further research is needed to better understand this phenomenon. The primary aim of the current study was to contribute to developing theories regarding the role that meaning-making plays in the forgiveness process, within the context of infidelity. To accomplish this goal, the following research questions were addressed: (a) how do individuals make meaning of their partner's infidelity? and (b) how does this meaning-making narrative impact the process of forgiveness? Semi-structured in-depth interviews were conducted with a community sample of seven Canadian adults (19+) who experienced infidelity and remained in their romantic relationships. Interpretative phenomenological analysis was used to analyze the data. Six core themes, each with their own corresponding subthemes, emerged from the data, including (a) experiences of undesirable emotions, (b) emotional processing, (c) meaning-making, (d) consideration of external stressors, (e) maintaining a positive perspective, and (f) new beginnings. The six themes are presented as a six-stage healing model which supported participants in constructing meaningful narratives of their partner's infidelity and ultimately allowing them to reach forgiveness and healing. The current findings have the potential support individuals in their recovery from infidelity by informing couples, mental health professionals, and training institutions.

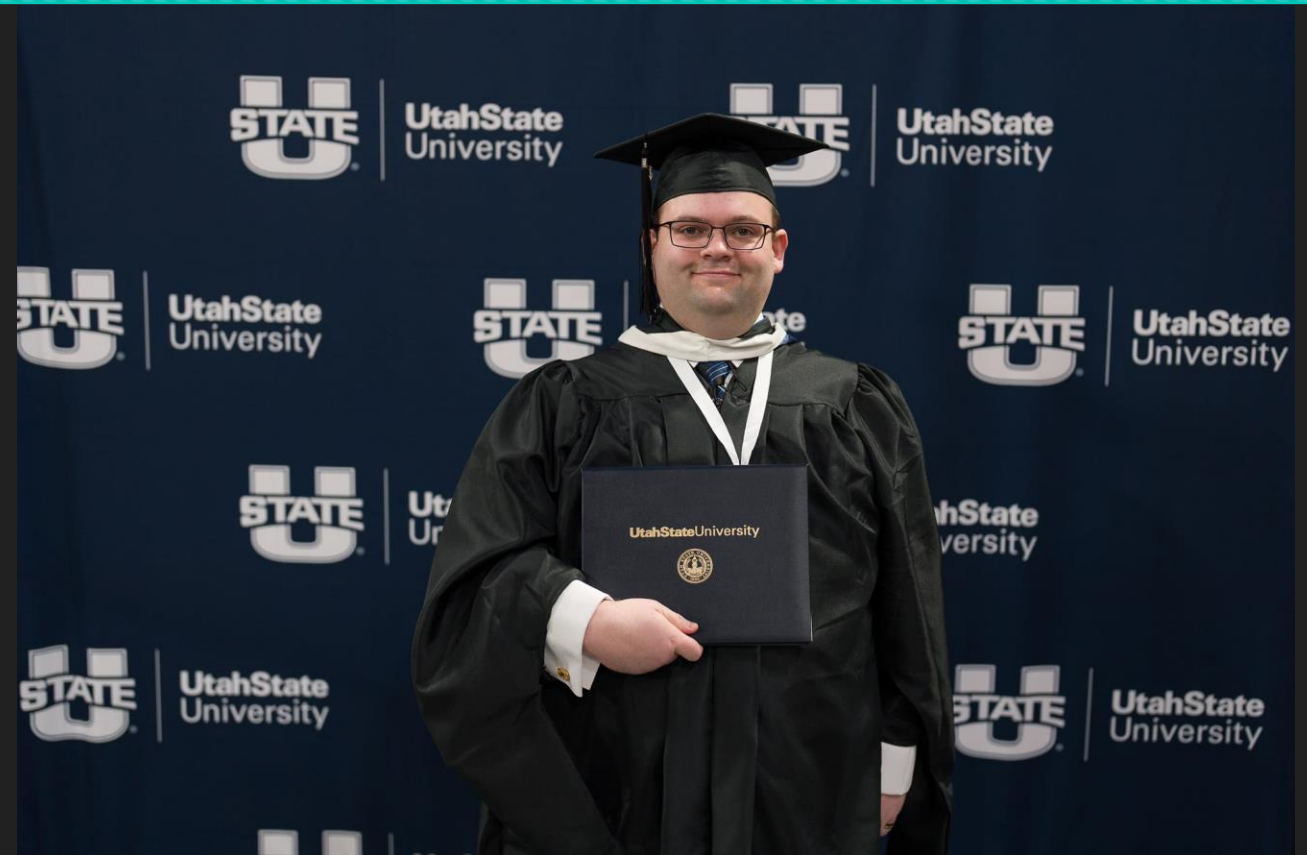

520	3	<p>The restrictions (i.e., stay-at-home orders and social distancing) implemented to reduce the spread of COVID-19 led to increased rates of stress, ultimately impacting people's romantic relationships which are vital to overall health and well-being. The aim of the current study was to investigate how COVID-related stress inducing factors (i.e., social isolation, financial strain, lifestyle changes, COVID-19 diagnoses, and psychological distress) have impacted couples' relationship quality and what key components of relationships (e.g., shared meaning, intimacy) might moderate this impact. The study used a correlational survey design, with a community sample of adults (19+) who were living with their romantic partners in Canada. The data collected were analyzed using SPSS Version 28 software. Results provide support for the hypothesis that a higher level of COVID-related stress would be related to poorer relationship quality. Specifically, social isolation and psychological distress had the strongest impact. The moderator variables, intimacy and shared meaning, were not found to mitigate this association. However, COVID-related stress only significantly impacted relationship quality for those who had a higher level of shared meaning, but not for those who had a lower level of shared meaning. The results from this study add to previous research on the impact of the pandemic on romantic relationships. The current findings have the potential to mitigate the adverse effects of the pandemic on couples' relationship quality by informing mental health professionals and couples. More specifically, treatment interventions that focus on how the pandemic impacted couples' shared meaning systems (e.g., rituals, goals, roles, and symbols) and how to improve these may be beneficial.</p>
